***Subject: Status of Distribution and Digitisation of Enumeration Forms during the Ongoing Enumeration Phase of Special Intensive Revision (SIR), 2026 in Bishnupur District.***

In pursuance of the instructions issued by the Election Commission of India, this Office hereby releases the current progressive status of the Enumeration Phase for the ongoing Special Intensive Revision (SIR) of Electoral Rolls, 2026, which commenced on the 30<sup>th</sup> of May, 2026. As of 6:00 PM today, the progressive **Distribution of pre-filled Enumeration Forms (EFs)** to electors of Bishnupur District stands at **99.98%**, while the **Digitisation** of these distributed forms via the BLOs, the official web portal, and the mobile application stands at **94.80%**. The **Enumeration Phase ends on 28<sup>th</sup> June, 2026** as per the schedule released by the Election Commission of India for the ongoing SIR.

2. To ensure the absolute accuracy of the electoral roll, all registered electors within Bishnupur District are called upon to fulfill their civic responsibility by filling in the requisite information pertaining to themselves or their family members and submitting the completed form without delay. It is explicitly clarified that **no supporting document is to be collected by the Booth Level Officer (BLO) from the electors during this enumeration phase.** For electors whose Enumeration Forms are not returned, the designated BLO will proceed to conduct mandatory verification with neighbouring electors to determine and document the specific reason for non-submission—such as **Absent, Shifted, Dead, or Duplicate (ASDD).** **This ASDD list, alongside the specific grounds for non-inclusion, will be officially published on the Notice Board of the Electoral Registration Officer (ERO) and hosted on the website of the Chief Electoral Officer, Manipur, for public transparency.**

3. For the convenience of the public, the Election Commission of India has established accessible **offline and online channels for the procurement and submission of these forms.** Under the offline mode, electors can obtain the partially pre-filled forms from their designated **Booth Level Officers (BLOs)** during house-to-house visits and must return the completed hard copies directly to them. Alternatively, under the online mode, electors can download and submit the forms digitally via the official web portal at **<https://voters.eci.gov.in>** or through the **ECINet mobile application.**

4. For clarification, administrative guidance, or verification regarding the Enumeration Forms and the ongoing SIR process, electors are advised to utilise the official **Toll-Free Voter Helpline Number by dialling 1950**. Dedicated personnel are available through this helpdesk to assist citizens with form completion, electronic uploading procedures, and BLO coordination.

5. In line with the directives of the Election Commission of India emphasizing that collective institutional engagement is vital for the successful completion of the SIR exercise, all **Booth Level Agents (BLAs)** appointed by recognised National and State political parties are required to participate proactively in this phase. The BLAs are urged to work in close coordination with the BLOs to facilitate public compliance, assist residents in form completion, and ensure total registration coverage across Bishnupur District.
