***Subject: Publication of Draft Electoral Roll in Bishnupur District in connection with the ongoing Special Intensive Revision (SIR) of Electoral Rolls, 2026.***

The District Election Officer, Bishnupur is pleased to announce the **publication of the Draft Electoral Roll** with qualifying date of 1<sup>st</sup> July, 2026 for all six Assembly Constituencies—24–Nambol, 25–Oinam, 26–Bishenpur, 27–Moirang, 28–Thanga, and 29–Kumbi—today, 5<sup>th</sup> July 2026, as part of the ongoing Special Intensive Revision (SIR) process.

2. The Draft Electoral Roll is prepared in accordance with the Registration of Electors Rules, 1960, and a copy thereof is **available for inspection** at the offices of the Electoral Registration Officer (ERO), Assistant Electoral Registration Officer (AERO) and Booth Level Officer (BLO) concerned during office hours. It is also available for download from the CEO's website at <https://ceomanipur.nic.in/>

3. The detailed verification exercise conducted by Booth Level Officers (BLOs) of the district during the recently concluded Enumeration Phase of the ongoing SIR process has yielded the following data:

Total Electors in the district before the Enumeration Phase and whose Enumeration Forms were printed	<b>1,88,054</b>
Total <b>Verified Voters</b> by BLOs	<b>1,81,775</b> (96.66%)
Total <b>Uncollectable Forms</b> by BLOs	<b>6,279</b> (3.34%)
Total Electors in the district in Draft Electoral Roll	<b>1,81,775</b>

4. To ensure complete public transparency, **the list of uncollectable forms**, alongside the specific grounds for non-inclusion i.e. **Absent, Shifted, Death, Duplicate, etc. (ASDD)** is **officially published** on the Notice Board of the Electoral Registration Officer (ERO) and hosted on the websites of the District Election Officer, Bishnupur at <https://deobishnupur.in/ASDD.php> and the Chief Electoral Officer (CEO), Manipur at <https://ceomanipur.nic.in>.

5. All eligible citizens are urged to meticulously check their names and particulars in the Draft Electoral Roll. Any claims for inclusion, objections to inclusion, or applications for correction of entries/transposition can be filed during the stipulated **period for filing Claims and Objections:**

- Start Date: **5<sup>th</sup> July 2026 (Sunday)**
- End Date: **4<sup>th</sup> August 2026 (Tuesday)**

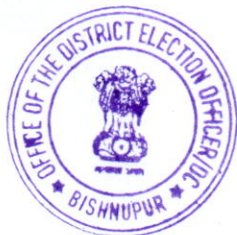
6. **Any eligible Citizen, who is going to attain the age of eighteen years on subsequent qualifying date in the year 2026 i.e. 1<sup>st</sup> October 2026, may also file his or her claim for inclusion** of his or her name in the roll, through Form-6, in advance, starting from the date of notice, and the same shall be considered and decided in the respective quarter of the year with reference to the respective qualifying date.

7. **The prescribed forms** (Form-6 for inclusion, Form-7 for objection and Form-8 for correction/transposition) **are available with all BLOs**. Additionally, a **Declaration Form** is required to be submitted along with Form-6/Form-8 for enrolment as a new elector/shifting from outside the state. All these forms are **also available for download** at <https://ceomanipur.nic.in/sir>.

8. Every such **claim or objection should either be presented at the offices of the ERO, AERO or BLO concerned** during the Claims and Objections period (as stated above) during office hours on all working days **or may apply online** via the Election Commission of India's (ECI) online platforms, namely the **ECINET** mobile application or the Voter Service Portal at <https://voters.eci.gov.in/>.

9. **Any person aggrieved by an order of the ERO regarding a claim or objection** possesses the right to prefer an appeal in accordance with ECI guidelines. Appeals against the decisions of the ERO must be filed with the District Election Officer (DEO), Bishnupur (i.e., the District Magistrate, Bishnupur). Such appeals may be submitted online via the aforementioned official portal or mobile application.

10. The cooperation of all political parties, government officials, and citizens is earnestly solicited.
