***Subject: Special Intensive Revision of Electoral Roll – Phase III.***

1. The Election Commission of India has directed to conduct **Special Intensive Revision (SIR) in the State of Manipur w.r.t. 01.07.2026** as the qualifying date in accordance with the schedule provided below:

Preparation, Training & Printing	20.05.2026 to 29.05.2026
House to House visits by BLOs	30.05.2026 to 28.06.2026
Rationalization of Polling Stations	By 28.06.2026
<b>Publication of draft Electoral roll</b>	<b>05.07.2026</b>
Period of filing claims & objections	05.07.2026 to 04.08.2026
Notice Phase/ disposal of Claims & objections	05.07.2026 to 02.09.2026
<b>Publication of Final Electoral Roll</b>	<b>06.09.2026</b>

2. During the Special Intensive Revision (SIR), 234 Booth Level Officers across the six Assembly Constituencies of Bishnupur district — namely 24-Nambol, 25-Oinam, 26-Bishenpur, 27-Moirang, 28-Thanga, and 29-Kumbi — shall perform house-to-house enumeration from 30<sup>th</sup> May 2026 to 28<sup>th</sup> June 2026. An Enumeration Form shall be provided to every elector by the Booth Level Officer; alternatively, electors may download the form from <https://voters.eci.gov.in>. Electors are requested to submit the completed Enumeration Form to the relevant Booth Level Officer or via the Election Commission of India website at <https://voters.eci.gov.in>. Booth Level Agents (BLAs) appointed by political parties shall support the Booth Level Officers during the Enumeration Phase.
